4.1 GM Report

Custodian Trust

- 1. We still need Proof of Address and verified ID for Waitangi, Roger and Teresa

Relationship Building

- 1. One idea is to relinquish some of the blocks of land for the hapu/marae to manage and leave the bigger block to the Trust to manage
- JJ will work with the whanau at Taemaro to maybe set up a Maori Reservation/Whenua Trust co-managed between Taemaro and KTB to manage those whanau who are living on the land - MOU between the Trust and Taemaro Marae
- 3. Geraldine has also mentioned in previous reports about a housing development, if we build homes we will need Taemaro whanau to agree to pay rent as they will not be for free
- 4. Ngati Rua would like to see the land area in question and the block maps for the farm
- 5. Geraldine to korero to Roger about the removal of Te Komanga Marae, the original physical claimant was Taupo Marae, Ngati Rua
